02/11 Play area equipment replacement Working Group

a) To RECEIVE an UPDATE from Councillors from the PAFC and the PC plan going forward. Nothing additional to report at this time.

02/12 Village Hall grant application

A discussion was held about the requirement for the floor re-sanding

It was RESOLVED for the parish council to pay for refurbishment of the main Memorial Hall floor at a cost of £1500 to be funded from earmarked reserves of £1,500.

The clerk will be in touch with the Village Hall Committee about the next steps.

02/13 Footpaths

The footpath report was discussed. All problems identified on the list have been reported. The clerk was asked to follow up with West Camel clerk about how they have managed stile repairs.

02/14 Annual Village Meeting

Cllr Norman and Mrs Jones will organise the event with administrative assistance from the clerk.

02/15 Highways and Traffic

a) Stolen signs

Flood Committee were asked to report how many signs they are now missing.

It has already been agreed that the Road Closure will be made permanent, but the actual work has not been done yet. Chair is in constant touch with Highways to find out when this will happen. In the meantime from 27th February the Temporary Traffic Order will not be in effect and the road cannot be closed.

The clerk was asked to ensure that all volunteers who presently close the road for the Temporary Parish are notified by email that they must not put the signs out after 27th February 2022. [Afternote: Council subsequently informed that Highways has made this Road Closure permanent just prior to the meeting date]
