Minutes of the Full Parish Council Meeting held via Zoom Conference Call Facilities on Monday 11th January 2021 at 7:30pm

Public Question Time

- QCPC was asked to acknowledge receipt of the Playing Field Committee (PFC) accounts, development plan and draft lease early October 2020; that the PFC has been paid rent; and that the Council should reconsider the decision of the Finance Committee to put Grant 2020/21 on hold.
