Minutes of the Full Parish Council Meeting held via Zoom Conference Call Facilities on Monday 9th November 2020 at 7:30pm

Public Question Time

There were 17 members of the public virtually in attendance during the Zoom meeting.

Immediately prior to the meeting members of the public were provided with the opportunity to speak. Members of the public were asked speak for up to the prescribed 15 minutes in total in the order in which they requested the Password to access this meeting by remote attendance (Zoom). No members of the public spoke.

- 01/11 Apologies for absence: No apologies were received.
- **02/11 Declarations of interest:** Councillor D Hewlett declared a personal prejudicial interest regarding item 12/11.
- 03/11 To approve as a correct record the minutes of the previous meetings held on 12th October 2020 to be signed by the Chair at a later date.

04/11 Action Points from Previous Meeting

- Footpath maintenance equipment has been purchased and delivered to Queen Camel.
- A meeting of the Flood Committee planned for 30 October 2020 was postponed.
- The planned informal meeting with the Playing Field Committee has been deferred until the latest Covid-19 restrictions are altered.

05/11 To receive County and District Councillor reports.

- o Covid-19 updates are provided by SCC; R rate in Somerset is 1.4;
- Phosphates issue affecting Somerset Levels and Moors (not whole of South Somerset), so SSDC is not resolving Planning Applications until agreement reached with the Environment Agency (no date provided); new staff have been appointed; there are difficulties in achieving target dates for determination;
- LGR business case submission are due by today; SoS decision is expected by Christmas 2020;
- In response to a questions, Cllr Lewis has spoken with SCC Highways and is awaiting decision on dualling A303 and consequent changes to Gason Lane and Traits Lane; there appears to be no plan should permission for A303 dualling not be granted.

06/11 Applications for bids to SCC Climate Emergency Community Fund

SCC has opened (1 October 2020) the first opportunity for bids to its £1m Climate Emergency Community Fund. 07/11 Grants 2021/22 Review

Finance & Risk Committee (29 October 2020) considered the Grants & Donations: Policy, Procedures and Application Form, adopted 15/7/13 and recommended some revision to Council for adoption of a revised policy. Several comments were provided including providing separate forms for Grants and Donations, proof of purchase, evidence of money spent and confirmation of any unspent money. The Policy will be brought back to next Council in December 2020.

Finance & Risk Committee (29 October 2020) considered the draft Community Benefit Fund policy. The Panel is suggested to be 5no. community representatives and 2no. Parish Councillors with the Council making decisions. The Policy will be brought back to next Council in December 2020.

09/11 Highway Works

a) Yellow lines bellmouth Mildmay Drive/ A359

Council considered its support or not of providing double yellow lines being placed at the bell mouth of Mildmay Drive and the A359 to prevent vehicles parking right on the junction, thus causing a highway hazard.

It was resolved to support a request that double yellow lines be provided by SCC at the bell mouth of Mildmay Drive and the A359
